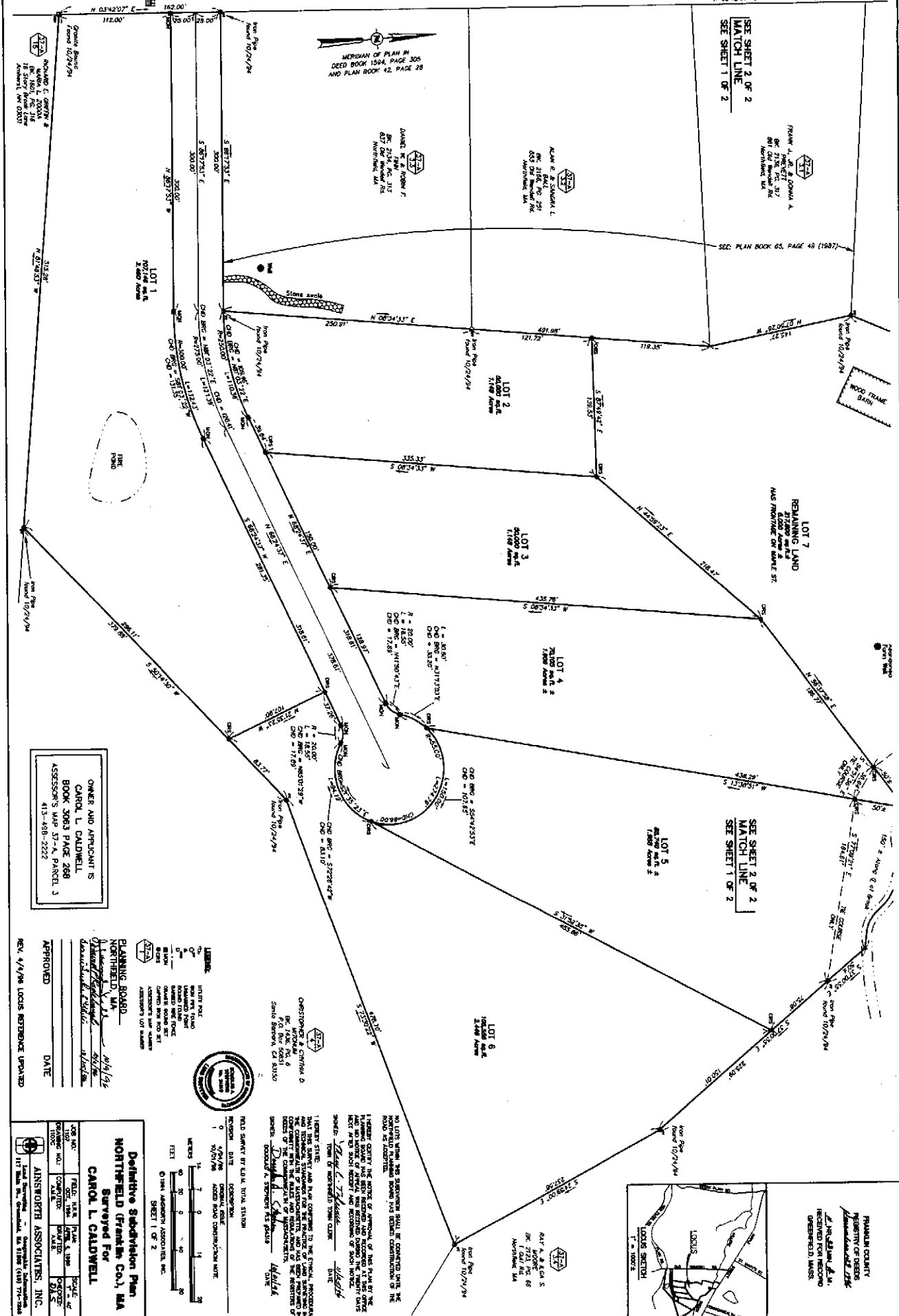


OLD WENDELL ROAD

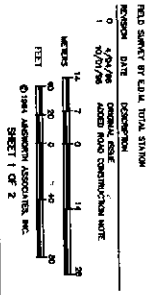
